

## CITY COMMISSION WORK SESSION MINUTES August 14, 2018

The Newton City Commission met for a work session on August 14, 2018. Present were Mayor Valentine, Vice Mayor Koehn, Commissioners Davis, Kreie and City staff. Commissioner Hague was absent.

The work session was called to order at 5:00 p.m.

**MOTION:** Commissioner Kreie moved and Vice Mayor Koehn seconded to go into executive session to discuss data relating to financial affairs or trade secrets of corporations, partnerships, trusts, and individual proprietorship; to consult with EDC Director Beth Shelton and City Development staff relating to financial affairs and trade secrets; to return to open session at 5:17 p.m. in the third floor conference room. Motion carried.

The Commission went into executive session at 5:02 p.m. and reconvened at 5:17 p.m.

**MOTION:** Commissioner Davis moved and Commissioner Kreie seconded to go into executive session to consult with the City Attorney on matters deemed privileged under the attorney-client relationship to receive legal advice; to returned to open session at 5:35 p.m. Motion carried.

The Commission went back into executive session at 5:30 p.m. and reconvened and 5:35 p.m.

**MOTION:** Mayor Valentine moved and Vice Mayor Koehn seconded to go back into executive session to discuss data relating to the financial affairs or trade secrets of corporations, partnerships, trusts, and individual proprietorships with Occidental staff; to return to open session at 6:05 p.m. Motion carried.

The commission went back into executive session at 5:35 p.m. and reconvened at 6:05 p.m.

**MOTION:** Mayor Valentine moved and Commissioner Davis seconded to return to executive session to discuss data relating to the financial affairs or trade secrets of corporations, partnerships, trusts, and individual proprietorships to return to open session at 6:15 p.m. Motion carried.

The Commission went back into executive session at 6:05 p.m. and reconvened at 6:15 p.m.



consult with Occidental staff and City staff regarding financial affairs and trade secrets; to return to open session at 6:35 p.m. Motion carried.


The Commission went back into executive session at 6:15 p.m. and reconvened at 6:35 p.m.
